Thai joint venture certified as Credit card Security Assessor Company "QSAC" ~To be Asia's No. 1 Credit Card Security Provider~

BroadBand Security Co., Ltd.(Headquarters: Shinjuku-ku, Tokyo, President and CEO: Akira Mochizuka, herein call "BBSec") will inform you that, Joint Venture BroadBand Security Assessment (Thailand) Company Limited (Location: Bangkok, Thailand Representative: Arsira Kawaree, herein call "BBSecTH"), established on January 3, 2020, has been certified by PCI SSC*1 as an international qualification "QSAC" *2 that can assessment compliance with PCI DSS*3, the international security standard for credit cards.

[Background]

In Japan, where the transition to a cashless society is accelerating, cashless security is one of the important measures of each government in the APAC area including Thailand.

In Thailand, PCI DSS is being developed as one of the security requirements for financial institutions under the Bank of Thailand and important contractors.

Under these circumstances, BBSec TH, as one of our important APAC bases, will fulfill its responsibilities as QSAC to financial institutions, entrusted companies, etc. that need to improve and maintain payment card security.
