Signed Memorandum of Cooperation (MoC) among Terilogy Co., Ltd., VNCS GLOBAL SOLUTION TECHNOLOGY JSC(VNCS-G)and BroadBand Security (BBSec)

~ To be Asia's No. 1 Credit Card Security Provider ~

We are pleased to announce that BroadBand Security, Inc. (Headquarters: Tokyo, Japan President and CEO: Akira Mochizuka, herein call "BBSec") has signed a memorandum of cooperation with VNCS GLOBAL SOLUTION TECHNOLOGY Joint Stock Company (Headquarters: Hanoi, Vietnam, CEO: hống Huy Hùng, hereafter "VNCS-G") and Terilogy Co., Ltd. (Headquarters: Tokyo, Japan, President: Akihiko Abe, hereafter "TERILOGY") to expand various business fields related to PCI DSS*¹ the international security standard for credit cards in APAC, and agreed to start a business alliance cooperation including a feasibility study for market development.

【BACKGROUND OF BUSINESS ALLIANCE】

In Japan, in an environment where the transition to a cashless society is accelerating, it is one of the important measures of each government in APAC. Under such circumstances, BBSec has established a joint venture (BroadBand Security Assessment (Thailand) Co., Ltd., hereafter "BBSecTH")) *² in Thailand in January 2020. Furthermore, in October 2020, BBSecTH has been certified by PCI SSC*³ as an international qualification "QSAC" *⁴ that can assessment compliance with PCI DSS, the international security standard for credit cards. In addition, Korean branch, which boasts the top share in Korea in this business, already has a track record of PCI DSS compliance activities in Vietnam.

Under these circumstances, we will expand the PCI DSS compliance support business in Vietnam together with VNCS-G and TERILOGY.

【THE NEXT DEPLOYMENT】

With the conclusion of this Memorandum of Cooperation, we will start a collaboration among three companies. BBSec aims to be APAC's No. 1 credit card security provider as the first Japanese company to be selected as a Japanese company in the "2020-2022 Global Executive Assessor Roundtable (GEAR)" of PCI SSC and will continue to expand its business with companies around the world.
